

## The Caesarstone Millionaire Competition Rules

Entry to this competition is by virtue of the successful registration of a Caesarstone Residential Warranty only. Only the homeowner of the installation is eligible to win.

Only entries where the Caesarstone warranty was successfully registered after the 1<sup>st</sup> of July 2019 and before the 15<sup>th</sup> February 2020 will be entered into the competition.

The Caesarstone installation relevant to the warranty registration must have been completed after the 1<sup>st</sup> of April 2019.

### DETAILED TERMS AND CONDITIONS:

1. The Caesarstone Millionaire Competition will commence on the 1<sup>st</sup> of July 2019 and terminate at midnight on the 15<sup>th</sup> of February 2020 (CAT).
2. The competition is applicable:
  - a. Where a Caesarstone **warranty registration form**, located on the Caesarstone website, has been successfully completed, submitted and received.
  - b. To **residential warranty** registrations registered between the 1<sup>st</sup> of July 2019 and the 15<sup>th</sup> of February 2020, in respect of Caesarstone installations completed after the 1<sup>st</sup> of April 2019.
  - c. To the **original owner** of the premises where Caesarstone has been originally and successfully installed in accordance with Caesarstone fabrication and installation guidelines.

  - a. Any commercial warranty registrations.
  - b. Any Caesarstone material supplied free of charge or that are installed for display purposes.
4. Only **one warranty** registration and therefore one competition entry per property is allowed.
5. Each eligible warranty will be allocated an official entry number, which will be detailed on the mail confirming the warranty registration.
6. The selection of the one winning entry number will be made electronically and randomly from the list of official entry numbers submitted to the auditors who will oversee the random selection process.

  - a. paid in a once-off, single payment into the winners' verified bank account.
